

FERPA: Access to Student Records

OFFICE OF REGISTRATION & RECORDS

In accordance with the Family Educational Rights and Privacy Act (FERPA) and University of Missouri Collected Rules and Regulations, this form allows a student to grant parents, guardians, spouse, and/or others access to their educational records maintained by the Office of Registration & Records, Cashiers and Collections Office, Financial Aid & Scholarships Office, and Residential Life.

- Anyone given access to a student's record may have access to ALL of the student's academic
 records. For example, a student cannot give a parent access to their billing information, but not
 give them access to view their grades.
- All permissions granted will stay in effect until revoked in writing by the student.
- Please note that it is University policy not to release student records over the phone. Requests should be made in-person at the above named offices and must be accompanied by appropriate photo identification.
